CO2 reduction result in FY2023

We could achieve the CO2 reduction target in FY2023.

Following tables show the discharged CO2 ratios to FY2019 (base line).

"Scope-1" and "Scope-2" are simple ratios to generated amount for each item

For scope-1, the ratio slightly increased. Main factor is the exchange some air conditioning devices in lwate factory (fuel; kerosene \rightarrow LPG). The conversion of LPG is larger than kerosene, but new devices need low electricity. On the other hand, we achieved reduction of gasoline in lwate factory.

For scope-2, we executed several countermeasures as below.

Installed the high efficiency device (laser cutting; CO2 laser → fiber laser, lwate)
Installed the solar powers (head office and lwate), and the threshold optimization (lwate)
Switching other electric power company that has lower conversion CO2 factor (lwate)

"Total" is basic unit; discharged CO2 amount / Sales

As you can see the following, we could achieve the CO2 reduction plan in FY2023.
